## **European Directive 2002/95/EC Restriction of Hazardous Substance (RoHS)**

As you may be aware, a new European Directive is currently being implemented globally and in preparation for this Directive we at ITW Plexus must ensure that we, along with all of our suppliers, are in compliance. The Restriction of Hazardous Substances (RoHS), Directive 2002/95/EC restricts the use of hazardous substances in electrical and electronic equipment. The substances, which are restricted, are as follows:

- a. Cadmium (Cd) Maximum Level 0.01% of homogeneous material by weight
- b. **Mercury (Hg)** Maximum Level 0.1% of homogeneous material by weight
- c. Lead (Pb) Maximum Level 0.1% of homogeneous material by weight
- d. **Hexavalent Chromium (Cr VI)** Maximum Level 0.1% of homogeneous material by weight
- e. **Polybrominated Biphenyls (PBB)** Maximum Level 0.1% of homogeneous material by weight
- f. **Polybrominated Diphenyl Ethers (PBDE)** Maximum Level 0.1% of homogeneous material by weight.

We are pleased to confirm the composition of the listed product(s) accompanying this letter, comply with the European Directive 2002/95/EC. This conclusion is based on one of the following facts; none of the listed substances are used as raw materials in our production process, and none of the listed substances are expected to form during the reaction process, and/or verification by independent laboratory testing.
